

Charging and Remissions Policy Statement

The Birmingham Federation of Maintained Nursery Schools follow the policies and procedures from Birmingham City Council including BCC Financial Procedures Manual and Birmingham Safeguarding Children Board (BSCB) which includes the Government's Prevent Strategy.

Rationale

The Governing Body of Allens Croft and Shenley Fields Nursery Schools recognises the valuable contribution that the wide range of additional activities, including trips, clubs and residential experiences can make towards pupils' education.

The Governing Body aims to promote and provide such activities both as part of a broad and balanced curriculum for the pupils of the school and as additional optional activities.

Context

The law states that education provided during school hours must be free. This definition includes materials, equipment and transport provided in school hours by the Local Authority or the School. No pupil may be left out of an activity because their parents cannot or will not make a contribution of any kind.

Aims

- To make school activities accessible to pupils regardless of family income.
- To provide a process which allows activities to take place at a minimum cost to parents, pupils and the school and;
- Which acknowledges the cost of such activities to the school's budget.

Charges

The governing body reserves the right to make a charge in the following circumstances for activities organised by the school:

- Residential Activities Taking Place Largely During School Hours The full cost to each pupil of board and lodging. Parents have the right to claim free activities if they are in receipt of the following state benefits:
 - Income Support
 - Income based Job Seekers Allowance

- Support under section VI of the Immigration and Asylum Act 1996
- Working tax credit and an annual income that does not exceed the published Inland Revenue threshold

Activities Outside School Hours

The full cost to each pupil of all approved activities deemed to be optional extras that are not a necessary part of the national curriculum.

Individual Instrumental Tuition

The full cost to the pupil for providing any instrumental tuition if the cost is not an essential part of the national curriculum or examination syllabus.

Remissions

There will be no obligation for any parent to make a voluntary contribution towards the cost of school activities and to the School Fund. Pupils will not be treated differently whether or not their parents have made a contribution.

The Governing Body may wish to remit in full or in part the cost of other activities for particular groups of parents, for example, in the case of family hardship. When arranging a chargeable activity such parents will be invited in confidence for the remission of charges in full or in part. The Executive Head Teacher in consultation with the Chair of Governors will make authorisation for such remission.

Voluntary Contributions

Voluntary contributions may be requested from parents/ carers to cover the cost of the following activities:

- cost of materials
- bus fares
- entrance fees
- school visitors
- healthy snacks

General

The Governing Body may from time to time, amend the categories of activity for which a charge may be made. Nothing in this policy statement precludes the Governing Body from inviting parents to make a voluntary contribution towards the cost of additional activities, which take place in school time. General

Daycare Provision

Where provided, our daycare and wraparound provisions (before/ after school and 'holiday club') charge for all additional activities in order to recover the full costs.

Parent/ Carer Groups

We may charge a nominal fee to parents/ carers for attendance at our groups (stay and play, musical babies etc.) Some groups may be run on our site by (Governing Body approved) third party providers and charge their own fees for doing so.
